Item 8 Gypsey Race (GR)

In response to the flooding on 6th July 2025, a local landowner intends to create a soakaway on Park Lane with a grip to divert water. NYC and the Parish Council will monitor the area to check whether these works alleviate the problem

Item 10 Footpaths

Cllr Pearce noted that an overgrown footpath at the junction of Wintringham Road and Wolds Valley Road had been strimmed by NYC

Cllr Ogden noted the poor condition of a cherry tree towards the west end of Main Street, West Lutton.

ACTION: Cllr Bell to inspect the cherry tree.

2025.09 Planning Application

ZE24/01627/MFUL

Extension to rear (North) of the existing industrial manufacturing unit and associated works Westfield Works, Main Road, Helperthorpe, Malton, North Yorkshire YO17 8TQ

Cllr Pearce advised those present that as the Planning Application had been granted there was little more that the Parish Council could do, but residents and other third parties do have the option of making a complaint to the Local Government Ombudsman.

Cllr Bell advised that one cut had been completed together with an amount of strimming work and that another cut would be arranged after the dry spell has ended.

- Cllr Pearce had received a letter from the Community Governance Review Team at NYC regarding a proposed change in Civil Parish boundaries with the transfer of two properties

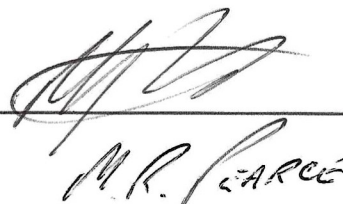
As there was no further business to be transacted the Meeting was closed by Cllr Pearce at 8:15pm.
